HELPFUL HINTS FOR COMPLETING THE FINANCIAL AID APPLICATION PROCESS

1. If possible, have federal tax returns completed before filing the Free Application for Federal Student Aid (FAFSA).
2. Be sure to complete every line of both the FAFSA and the Lebanon Valley College Institutional Data Form unless specifically instructed to skip an answer or section. DO NOT leave anything blank. (If you did not receive funds from a particular source, place a zero (0) in the blank.)
3. Make sure all forms are **signed** and dated.
4. Be sure to list Lebanon Valley College (Title IV School Code is #003288) on the FAFSA. If you already completed your 2010–2011 FAFSA but did not list Lebanon Valley College on it, please make the correction online by accessing your FAFSA at www.fafsa.ed.gov or contact Federal Student Information at 1-800-433-3242. You must have your DRN (Data Release Number), which is listed on your Student Aid Report (SAR), in order to add an institution over the phone.
5. All required information **must** be submitted before a financial award package will be prepared.

INSTRUCTION SHEET
Steps Required to Complete the Financial Aid Application Process

Information/forms that LVC requires in order to award need-based aid:

1. The 2010–2011 Free Application for Federal Student Aid (FAFSA)
2. The Lebanon Valley College Institutional Data Form for the 2010–2011 Academic Year (attached)
3. If your record is selected by the federal government to undergo a process called verification, our Financial Aid Office will provide you with a Verification Worksheet. You will need to complete the Worksheet and return it to us, along with **signed** copies of parent and student 2009 federal income tax returns and W-2 forms. **Only families contacted by our office will need to complete this step.**

Deadlines for filing the above information:

1. Fall 2010 new Freshmen and Transfer Students: The priority deadline for all applicable information listed above is March 1, 2010.
2. Spring 2011 new Freshmen and Transfer Students: The priority deadline for all applicable information listed above is November 1, 2010.
3. Returning students: All of the above information that is applicable to the student must be submitted by April 1, 2010.

Where to submit your information:

1. The 2010–2011 Free Application for Federal Student Aid (FAFSA) should be submitted to the federal government processor online via **www.fafsa.ed.gov** or in the envelope provided with that application. A paper application is available only by contacting Federal Student Information at 1-800-433-3243.
2. The attached Institutional Data Form should be mailed to **Lebanon Valley College, Financial Aid Office, 101 N. College Avenue, Annville, PA 17003-0501** or faxed to **717-867-6027**. Do not mail the hard copy if you have faxed it.

Applying for a state grant:

1. The FAFSA serves as the initial state grant application for all states.
2. Pennsylvania residents are not initially required to submit any application material other than the FAFSA; however, the Pennsylvania Higher Education Assistance Agency (PHEAA) may request additional information from the family. This information should be submitted to the agency as soon as possible. The PA state grant deadline for submitting the FAFSA is May 1, 2010. Meeting the institutional deadlines listed above ensures full consideration for PA state grant eligibility.
3. Students residing in states other than Pennsylvania should contact their state's higher education agency for application information.
