## Photo Portrait Contest

This photo contest is being offered in conjunction with the Arnold Newman: *Luminaries of the Twentieth Century in Art, Politics and Culture* exhibition in the Suzanne H. Arnold Art Gallery at Lebanon Valley College from January 20 – March 18, 2012.

**Who may enter:** This Photo Portrait Contest is open to students in grades 9-12 and college.

**How to enter:** All entries must be delivered to the Lebanon Valley College Art Department Office in Lynch, room 164, by 4 p.m. Friday March 2, 2012. Entries may be picked up at the Suzanne H. Arnold Art Gallery Saturday, March 24, 11 a.m. – 2 p.m. and Sunday, March 25, 11 a.m. – 3 p.m.

### Contest Rules:

- Entry must be the original creation of the subject in portrait format only.
- Photograph must have been taken within the last year.
- Portraits may be processed in black/white or color, digital or film.
- Maximum portrait size is 16"x 20".
- Photograph must be matted or dry-mounted.
- A *Release of Photo Subject to Display* form must be attached to the back of the photograph. (see page two)

**Release Form:** In the case of a minor (18 years or younger), the subject's parent or guardian should complete the release form and attach it to the back of the matted photo.

**Awards and Exhibition:** The winning student portraits will be notified of their status via email by March 9, 2012. Cash awards will be *three \$50 prizes*. Award photos and honorable mention photos will go on display on the Lebanon Valley College Campus.

**Conditions:** The decisions of the Judges are final and binding with respect to all matters relating to the Contest. If the entrant wins, the winning photographs and each winner's name and photograph may be used in conjunction with the Suzanne H. Arnold Art Gallery, or Lebanon Valley College. By entering, you agree to the contest official rules.
